- Introductions
 - Each member introduces themselves with one interesting fact about themselves
- Context and Alignment on the Goals and Objectives of the Diversity Equity & Inclusion Summit
 - Start working and planning for the DEI Summit; essential to have a common alignment
 - Goal: to host and facilitate a town-wide DEI Summit this coming fall; set this up, facilitate it, and make it a memorable event and experience
 - Investment and reflection on challenging period nationally; reckoning towards racism and equality
 - Reflected locally; DPS events exasperated and brought impetus
 - We as a community locally have responded and our taking action in response to national and local events
 - BoS Proclamation; commitment to ensuring town is safe, welcoming community that embraces DEI
 - This meeting today is a first step in making that proclamation come alive
 - Build upon community endeavors that are already happening
 - o re: Sandy's Clipper proclamation
 - o DPS, DFL active in this are in terms of education initiatives

- o DBMS has an outreach program to provide access
- Race Amity, Interfaith Council, Stand Up Duxbury, Duxbury for All
- Police department involved as well as non-govt and non-profits
- DRHS uncovering past history and bringing to our forefront
- Objective: What are we as a community doing, what are we not doing
 - Summit is opportunity to harness activity, leadership
 - o Bring efforts together and energy together to truly move the needle forward using the current momentum
- Feedback from members:
 - SS: Very well stated; important to note that leadership on this issue is coming from the top, from BoS; often that is not the case
 - Accentuates this is a big undertaking and needs to speak to the values of our community
 - Not starring something but capturing the momentum that already currently exists
 - FG: Does objective seem attainable?
 - o JH: Yes; some of the work is being done already
 - Building from a place of learning and understanding but have a strong foundation
 - Should we consider some required reading? We all bring expertise but some have more than others, do we leverage or need to equalize?
 - MP: Goal is to host and facilitate town-wide DEI event; outcome is to understand what we are doing and not doing - How do these align?
 - FG: Groups are taking action and making a difference; level of activity so the first step is to understand the work going on (what is it? Get a sense of where we are); then through all this good work, perhaps there are pieces missing
 - Paint a picture of what's going on and what we need to do
 - MP: host and facilitate a conceptual framework where we place folks into different categories then step back and take a look at what we are doing

- CC: BoS statement is rich but there is a possibility that we don't live these words; summit is opportunity for town orgs to come and discuss how to make the statement real; expect summit will allow for creative thoughts to spark and discuss possibilities
- JH: break out BoS understand, address, and enact changes; goal is that the diverse groups of Dux are on the same page and connected
- FG: Potential to repeat summit to check in on progress and see what resources groups need; community wide approach
 - It's the BoS proclamation; how do we get the greater community to own it?
- SS: granular action words; for example move away from work proclamation and move to commitment
 - Invited to join a commitment
- DK: From DPS, prioritized DEI in our school community
 - Is it possible to bring in the viewpoint to bring in those who don't believe this is a number one priority? How do we respect all voices? Alternative viewpoints to come to a community consensus
- FG: All must be included; voices need to be heard
- JH: who, what, where, when, and how of summit
 - BoS Proclamation becomes mission/commitment
- FG: first step as committee to be sure all aligned and on the same page
- SM: understand goal, makes good sense, big undertaking but looking forward to the work
- KW: appreciate DK's point; the group is a diverse cross-section of community, however, the greater community has discord and the way forward is to try to include all voices in summit
- MP: Large undertaking; the more conversations we have, the close we will get to developing meaning

- How do we as a body form norm and storm as we look ahead to the work down the road?
- JM: Looking forward to next steps but this is an ongoing process and we don't leave unfinished business on the table; whole community involved
- FW: Agree with JM; maintenance and follow-through; have the biggest impact as possible, including all voices
 - Present to all, understand all perspectives, include the critical voices
 - Model positive behavior for our young adults in the community
- CS: Meaning-making is crucial to develop a community backed endeavor; has to start with a respectful conversation even when, and especially when, we disagree
- DK: Using language that entire community can get behind; build collaboration not divisiveness to get at our fundamental values
- VM: Sounds like we are making headway and this sounds consistent with committee goals, objectives

Next Steps

- o BoS: Adopted on Feb 1; adopted again on March 29
 - Share proclamation with all boards and committees; this has been done
 - Originally wanted each board/committee adopt, but instead all boards/committees/dept heads understand the proclamation
 - Posted and distributed to all
 - o This was first step, now turning these words into action
- Next meeting will discuss the who, what, where, when, and most importantly how
 of summit
- Next Meeting: Monday, 7pm
 - Depending on Gov. Baker legislature; need physical quorum (7 people) then six can join remotely; FG will keep us updated
 - JM: can make two rooms available at Senior Center if folks are more comfortable in smaller groups
