MINUTES OF MARCH 1, 2024 DUXBURY, MASS.

The Duxbury Community Preservation Committee met remotely at 12:30 p.m. on Friday, March 1, 2024 in the Town Hall Mural Room.

ANNUAL TOWN MEETING COC ARTICLE REVIEW

Ms. Morris reported that the Town received one bid from Burgees for \$21,000 to complete the work on the clock faces, hand, and numbers. The mechanicals will not be touched. Ms. Morris suggested asking for \$25,000 at Town Meeting to allow for a contingency. A discussion followed on the history of the clock.

Ms. Leing made a motion, seconded by Ms. Cross, to approve \$25,000 for Article 29 at the 2024 Annual Town Meeting. The motion passed unanimously 5 to 0 on a rollcall vote: Ms. Palmer: yes; Mr. Kelso: yes; Ms. Leing: yes; Ms. Cross: yes; Ms. Morris: yes.

CONSERVATION PARKING

Ms. Rufo is considering options for parking at Ricker bogs. She has received a quote from Armstrong Fence, but given the sensitivity of the fresh fruit bogs, dogs are prohibited from Ricker. Ms. Rufo has received feedback that creating parking will encourage dogs. Ms. Rufo requested the Committee's feedback on the type of parking that should be constructed. A discussion followed on locations for potential parking areas along Mayflower Street and signage options. Ms. Morris is going to contact Ocean Spray's food science director to see what type of signage, monitoring and enforcement Ocean Spray has.

Ms. Rufo reported that Nancy O'Connor is posting a CPC meeting 8:30 a.m. on March 9. Ms. Cross proposed meeting at 12:30 p.m. instead.
