  - o FW: Debunk fallacies that exist; a forum of transparency and honesty
  - JM: All department heads should continue to work together with similar information & similar communication
- Maintaining inclusivity and respectful language in Duxbury: group discussed recent letter sent by school department as well as the Black Lives Matter flier stolen twice from First Parish
  - O JH: Table at Town Meeting; lots of resources with engagement and interest from community members; testament to many folks interest in this ongoing work
    - Brochure includes link to all events and showcases the many town departments engaged with this work in the community
    - The proclamation is meant to be a living breathing document; intention of brochure showcases the change, and grassroots work thus ensuring the proclamation is actionable
    - Committee will continue to amplify and support the ongoing work
    - International Peace Day: September 21st; planned by Race Amity / Interfaith group opportunity to bring folks together and celebrate what we have in common
      - FG: Can this committee partner?
      - JH: Yes definitely
      - FG: Should we bill our community event on the same day as International Peace Day?
      - JH: Will connect with DFL and confirm
  - o KW: Juneteenth celebration in Hingham, 2-6p on 6/19; throwing it out there for folks on this committee to attend, partner, and support in anyway possible
