

Discussing strategy with respect to collection bargaining (Duxbury Police Union, MCOP Local 376B and Duxbury Police Commanders Association, MCOP 376) since an open meeting may have a detrimental effect on the negotiating and bargaining position of the Town; and if the Chair so declares, in accordance with Mass. General Laws Chapter 30A, section 21, the Selectboard will adjourn and re-convene in Open Session on or about 9:45am immediately after completion of this Executive Session.

"As Chair, Ms. Ladd Fiorini declared that the necessity for an Executive Session to conduct strategy sessions regarding contract negotiations/collective bargaining, as to do so in an Open Session may have a detrimental effect on the Town's bargaining, strategizing and negotiating position."
